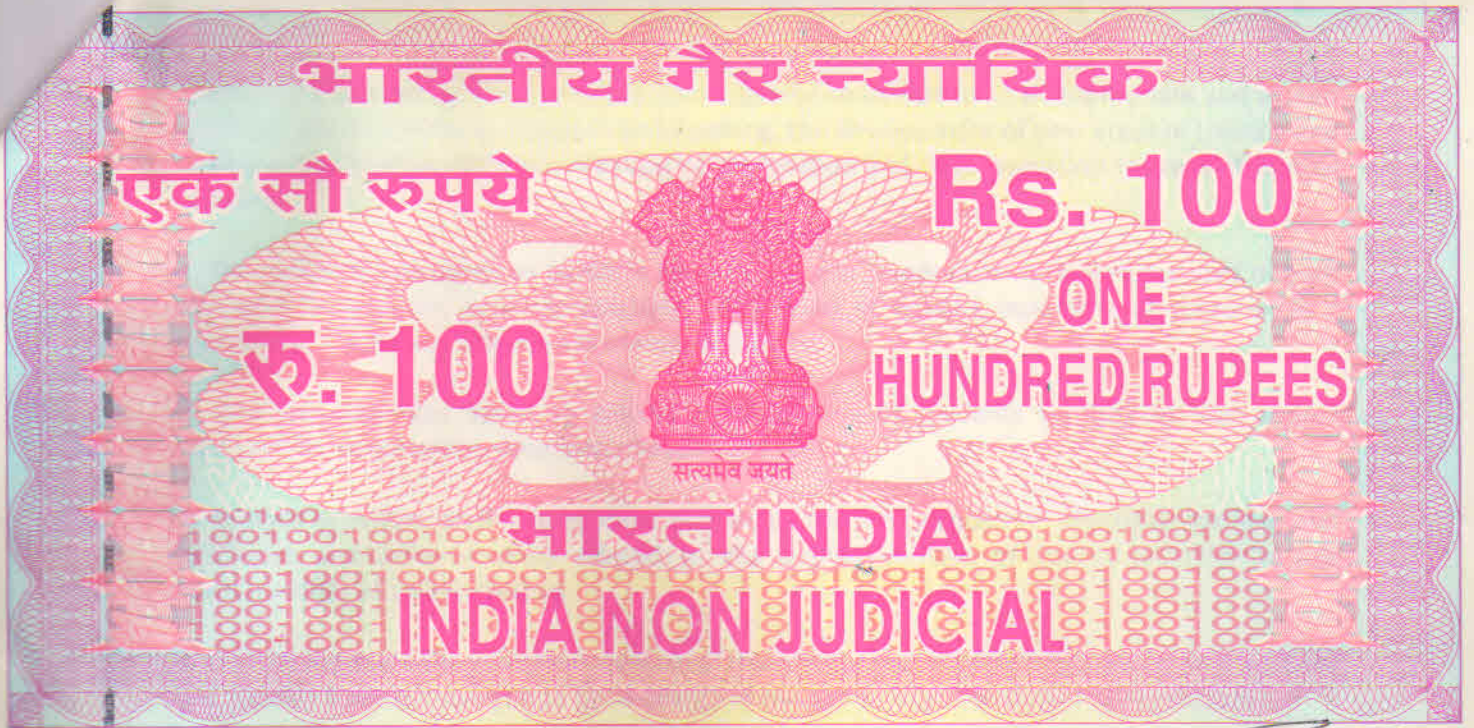

This MEMORANDUM OF UNDERSTANDING ("MOU") is executed on this 13<sup>th</sup> of July, 2017 at Coimbatore by and between:

1. GEM Hospital, Coimbatore - most advanced tertiary health care center, in the field of gastroenterology and laparoscopic surgery having its premises at 45, Pankaja Mill Rd, Ramanathapuram, Coimbatore - 641045, Tamil Nadu (hereinafter referred to as "GEM Hospitals"),
2. JSS College of Pharmacy, Ooty - a constituent college of JSS University, Mysore and having its principal office at Rocklands, Ooty (hereinafter referred to as "JSSCPO", which expression shall, unless repugnant to the meaning and context thereof, be deemed to include its successors and permitted assigns), of the **SECOND AND THE LAST PART**.

GEM Hospitals and JSSCPO may hereinafter collectively be referred to as the "Parties" and individually each of them may be referred to as a "Party".

**WHEREAS:**

This document constitutes a Memorandum of Understanding between JSS College of Pharmacy, Ooty, The Nilgiris and GEM Hospitals, Coimbatore, Tamilnadu (hereinafter referred to as "the two institutes") to engage in a program of co-operation.



1. The two institutes agree to promote exchange and co-operation in all appropriate and agreed academic areas of training, research and teaching, the development of new areas of training and teaching, and sharing and dissemination of information and documentation in areas of mutual interest.
2. The two institutes agree to facilitate exchange of and co-operation between the staff of both institutes in research, training, teaching, supervision of studies, mounting of conferences / workshops / CMEs and other areas of mutual interest.
3. The two institutes agree to discuss the exchange of students wanting to visit and/or participation of education programs of each institute.
4. Specific activities, staff and student exchanges for the purpose of internship training and education and other matters related to the implementation of this is included in this Memorandum of Understanding.
5. In order to ensure the good management of this Memorandum of Understanding, each institute will appoint a person within it to be in-charge of the day-to-day operation of this program.
6. This Memorandum of Understanding shall be effective for five years; from the date of signing in the first instance and shall be subject to change, renewal and termination by mutual consent. A party may terminate this Memorandum of Understanding for convenience and at any time and for any reason by giving six months' notice in writing to the other party.
7. This Memorandum of Understanding shall be construed and governed in accordance with the laws of India.
