### Procedure:

- 1. Candidates attending institutional offline mop-up round counseling should satisfy the eligibility requirement as per the NEET UG Information Brochure - 2019 and the minimum eligibility requirements as prescribed by the Dental Council of India regulations for admission to UG Dental (BDS) course.*
- 2. The seats will be allotted through Institution offline mop-up counseling based on the inter-se merit in NEET UG 2019 All India Rank.*
- 3. The physical presence of the candidate at the counseling is mandatory.*
- 4. Only the candidate & one parent will be allowed into the counseling hall.*
- 5. From the Vacancy arising after the completion of NRI category institutional offline mop-up round counseling admission, vacant seats will be transferred to the Management seats (Unreserved Category) and will be filled from the **candidates who have registered during the registration schedule**. The unregistered candidates will not be permitted to attend the counseling and admission process*
- 6. The candidates will have to submit their original certificates and also pay the prescribed fee before 4:00 PM on the date of counseling.*
- 7. The Candidates who are not able to comply with the above requirements will be deemed to have forfeited their seats and the same will be made available to the next available merit candidate.*
- 8. The candidates will have to satisfy the eligibility requirements for admission to BDS program as prescribed*

For NRI/ NRI Sponsored Category, in addition to above, the following documents have to be submitted at the time of reporting and admission to the college.

3	Affidavit from the sponsorer that he / she will sponsor the entire course fee of the candidate.

**IMPORTANT NOTE:**

- *There will be active verification of the NEET UG 2019 All India Rank submitted by the candidate with the information available in the un-allotted candidate list provided by the MCC of DGHS. Candidate whose NEET All India rank does not match with the information in the MCC website will be disqualified from the counseling process.*
- *The physical presence of the candidate at the counseling is mandatory.*
- *Only the candidate & one parent will be allowed into the counseling hall.*
- *Candidate should sign the attendance register to mark their presence and fill the registration form available at the registration counter*
- *Candidates will be called as per their **NEET All India Rank 2019** for document verification. Successful candidates will be allotted seats according to their All India NEET rank and number of seats available. Such candidates should produce their original documents for verification and pay the first year fees at the time of counseling. **JSS AHER will not entertain any requests for extension in this regard.***

***Absence of the candidate at the indicated reporting time and date will result in the instantaneous forfeiture of any claim for a seat.***

***The choice of course made by the candidate is final and binding and cannot be altered later under any circumstances.***

***After Admission:***

- *Provisional Admission Order and receipt for the payment made will be given to the candidate on completion of the admission process.*
- *Candidates who require hostel facility should report to Chief Warden of the allotted campus for hostel enrollment. Hostel will be allotted on payment of hostel fees only.*
- *Candidates should report to the allotted college on or before the reporting date mentioned in the admission order.*

**Mode of Payment:**

- 1) At the time of reporting for admission, candidate has to pay the first year fee in full to the JSS Dental College for further processing.
- 2) The payment can also be made by transfer of equivalent Indian Rupees from the NRE account of the Sponsor. However, this should be supported by a letter from the Banker stating that the amount is from the NRE account of the Sponsor.

**IMPORTANT NOTE:**

- Part payment or payment in installment is not permitted. Non-payment of the first year fees on the day of counseling will result in instantaneous forfeiture of seat.
- The candidates will have to pay the prescribed fee before 4:00 PM of the date of counseling. Only Demand Draft or wire transfer will be accepted towards fee.
