**Eligibility:** The MCC registered and unallotted candidates are only eligible for registration and participation for **Institutional offline mop-up round of counseling 2020** for the vacant seats followed by counseling and seat allotment which will be done on inter-se merit in NEET UG 2020 All India Rank. Candidate's name/details should appear under NEET Qualified un-allotted Candidate list to be shared by MCC of DGHS.

## **Procedure:**

- 1. Candidates attending institutional offline mop-up round counseling should satisfy the eligibility requirement as per the NEET UG Information Brochure 2020 and the minimum eligibility requirements as prescribed by the Dental Council of India regulations for admission to UG Dental (BDS) course.
- 2. The seats will be allotted through Institution offline mop-up counseling based on the inter-se merit in NEET UG 2020 All India Rank. Amongst the candidates present on the said date and time. No cancellation will be entertained after this admission.

#### 3. The physical presence of the candidate at the counseling is mandatory.

- 4. Only the candidate & one parent will be allowed into the counseling hall.
- 5. The candidates will have to submit their original certificates and also pay the prescribed fee before 2:00 PM of the dates of counseling mentioned, otherwise the seat allotted get cancelled without any prior notice.
- 6. The Candidates who are not able to comply with the above requirements will be deemed to have forfeited their seats and the same will be made available to the next available candidate on merit basis.
- 7. The candidates will have to satisfy the eligibility requirements for admission to BDS program as prescribed

**IMPORTANT NOTE:** There will be active verification of the NEET UG 2020 All India Rank submitted by the candidate with the information available in the MCC website. Such of those candidates whose NEET UG 2020 All India rank does not match with the information in the MCC website will be disqualified from the counseling process.

# On the day of Counseling

- 1. The physical presence of the candidate at the counseling is mandatory.
- 2. Only the candidate and parent will be allowed into the campus & counseling hall. This is done in view of the COVID situation and the safety of all.
- 3. Candidate should sign the attendance register to mark their presence.
- 4. Candidates will be called as per their NEET UG 2020 All India Rank for document verification. Successful candidates will be allotted seats according

to their All India NEET UG 2020 rank based on the number of seats available under All India Category. Such candidates should produce their original documents for verification and pay the first-year fees at the time of counseling. JSS Academy of Higher Education & Research will not entertain any requests for extension regarding fee payment.

- 5. The option exercised by you with regard to selection of the course of study at the time of counseling will be final.
- 6. Absence of the candidate at the indicated reporting time and date will result in the instantaneous forfeiture of any claim for a seat.

#### **After Admission:**

- 1. Admission order/Provisional Admission Order and receipt/s for the payment made will be given to the candidate on completion of the admission process.
- 2. Candidates should report to the allotted college on or before the reporting date mentioned in the admission order.
- 3. Candidates who require hostel facility should report to Chief Warden of the allotted campus for hostel enrollment. Hostel will be allotted on payment of hostel fees only.
