JSS HOSPITAL *JSS Hospital, Mysuru. (JSSH)*

The new JSS Hospital is a 1800 bedded teaching and service oriented hospital, attached to JSS Medical College (JSSMC). It also has one of the biggest critical and emergency care facilities with 260 beds and is one of the renowned high tech tertiary care referral hospitals in South India having to its credit several super specialties and latest advanced equipment. This hospital has additional supporting paramedical training facilities in the form of College of Nursing, College of Physiotherapy and School of Nursing. Quality health care is given free of cost for the poorer section of society.

The hospital is located in an area of 12.5 acres and has a built-up space of 12.5 lakh sq ft. and provides service in 37 specialties / super specialties with special clinics. It plans to cater to the healthcare needs of more than 16,000 outpatients in addition to the existing number of 18,000 and 3,500 inpatients every month.

The hospital has installed a whole body C.T. Scan (128 slice) and high resolution 3-Tesla MRI.

The drug center in hospital premises works round the clock and supplies drugs to patients at rates cheaper than those in the market.

It will be seen from the above particulars that the JSS Hospital is one of the biggest hospitals in Mysuru city and it has all the required facilities and infrastructure in the various departments and is fully equipped to render specialized medical treatment and diagnostic procedures.

ADMISSION PROCEDURE

The process of online registration & submission of online application form and

Instruction:

- 1. Candidates are advised to read the Information Bulletin carefully before starting “online registration and filling of online application form” and ensure that no column is left blank.*
- 2. Candidates have to provide all the information required for each entry during filling of online application.*
- 3. Candidates can register for admission to MBA in Pharmacy Administration Programmes only through “Online”.*
- 4. Before filling application form, please scan and store the latest Photograph and Signature as separate files in JPG format only. The same needs to be uploaded as required during the ‘On-line Application’ process.*
- 5. JSS Academy of Higher Education & Research - Information Bulletin is available on website and the same can be downloaded from the Website: www.jssuni.edu.in*
- 6. Registration and submission of online application form may be made by accessing JSS Academy of Higher Education & Research Website: www.jssuni.edu.in and Instructions for Online submission of Application Form are available in the Information Bulletin.*
- 7. Online registration and online submission of applications can be accessed from 02.05.2018 (Wednesday) from JSS Academy of Higher Education & Research website.*
- 8. The prescribed registration fee of Rs. 1540/- should be remitted through payment gateway provided using a debit card (issued by a bank in India) OR a credit card OR through internet banking. There is no provision for Offline payment.*
- 9. Candidates should take the printout of the application form on A-4 Size sheet of paper. Affix the original passport size photo and the same should be produced during document verification at the time of admission process along with originals.*

10. *Candidates are requested NOT TO SEND PRINT OUT of the online application and any other document to the University office.*
11. *Selection will be made on the merit based on marks secured in Qualifying examinations in relevant subjects conducted by various Universities and an entrance examination.*
12. *Seat will be allotted to the eligible candidates, subject to pass in interview as per JSS Academy of Higher Education & Research policy.*
13. *The admission will be done at JSS Academy of Higher Education & Research, JSS Medical Institutions Campus, Sri Shivarathreeshwara Nagar, Mysuru – 570 015, Karnataka.*
14. *His / her admission to the course will depend upon the fulfilling all eligibility criteria at the time of admission.*
15. *At the time of reporting for the admission, the candidate is required to produce the documents (original and three sets of photocopies) list mentioned above. If the candidate is admitted to the course, these documents will be retained by the University till he / she completes the course. If the candidate fails to produce all or any of the documents listed mentioned above he / she will instantaneously forfeit his / her claim for a seat.*
16. *The JSS Academy of Higher Education & Research website: www.jssuni.edu.in is updated regularly and suggests all candidates to visit it frequently for relevant information.*

Instructions to the candidate:

Admissions:

70% of seats will be admitted to the course, MBA in Pharmacy administration, on the basis marks secured in qualifying examinations in relevant subjects conducted by various Universities.

- *15% of total seats are reserved for NRI / Foreign Nationals.*
- *15% of the total seats are reserved for Institutional Preference (IP).*

Qualifications/Eligibility:

Requisite qualification for admission to MBA in Pharmacy Administration.

- *The candidate seeking admission must hold a bachelor's degree in any discipline or an equivalent qualification with minimum of 50% marks aggregate. (In case of SC, ST and OBC Candidate the minimum should be 40% marks aggregate)*

Documents to be produced in original at the time Admission:

- 1. S.S.L.C./Equivalent examination marks card.*
- 2. P.U.C./Equivalent examination marks card.*
- 3. Graduation marks cards (each year/semester)*

- 8. Foreign nationals seeking admission should obtain eligibility certificate issued by

- 10. Identity Proof (e.g. Aadhaar Card/ passport/voters card/pan card/driving license)*
- 11. Parent's Aadhaar and PAN card photocopy.*

NOTE ON ONLINE APPLICATION PROCEDURE:

Candidates have to register and enter the application details through **online** to become eligible for admission to MBA in Pharmacy Administration course for the academic year 2018. The conventional method of pen and paper filling of form is done away with from 2017. Please note the following:

- Online registration and application is a user-friendly process.
- First candidates have to register their names providing requested detail in the first step of the online procedure and after getting login details, candidate can login and fill up the online application form through JSS Academy of Higher Education & Research
- website: www.jssuni.edu.in
- Before filling application form, please scan and store the latest Photograph and Signature as separate files in JPG format only. The same needs to be uploaded as required during the 'On-line Application' process.
- Most of the fields will be only a selection from the readily available information; and all the fields are self-explanatory with dropdown menu the candidates have to select the suitable / appropriate items from the drop down list wherever applicable.
- The candidates have to select the declaration after confirming themselves that there are no changes to be incorporated or all the entries made by them in the online application are correct.
- After declaration by the candidates, the prescribed registration fee should be remitted through payment gateway provided using a credit card OR a debit card issued by a bank in India OR through internet banking.
- Once the declaration is done, there is no provision to change / edit / delete / add any information to the entries already made by the candidates.
- Candidates are informed to make sure that the entries made before declaration are correct.
- After completion of all the processes, the candidate must ensure that a print out of his/her application is to be downloaded and produced at the time of entrance test & counseling along with required documents.
- Please note that, the registration fee paid is **NON-REFUNDABLE**.

METHOD / STEPS FOR APPLYING:

Before entering the application form online, the candidates are advised to download the blank application form and take two or three photocopies of the same and practice on them in the prescribed manner.

- **PLEASE NOTE:** *The finally submitted application details through online by the candidates will be the candidate's data for all further processing in the JSS Academy of Higher Education & Research computers. Therefore, the candidates are advised not to make any mistakes while making entries in the form and not to upload any documents / papers (Except Photograph & Signature) in support of their claims to the filled application form, Candidates are requested not send print out of the online application and any documents to the University office.*

Steps:

- Step 1:** *Candidates are required to select and click on “Admission notification” on the home page by browsing URL on Website <http://jssuni.edu.in> & Select < Apply Online >*
- Step 2:** *Candidates are required to register their name by selecting the course from the drop down list and providing all the required information for registration process. After successful registration, a registration number will be displayed on the screen. The system generated email will be sent to their registered email-id.*
- Step 3:** *Candidates are required login to the system with the user ID, DOB & verify the details by entering verification code.*
- Step 4:** *Once the candidates complete the student information entries, they will have to upload the photograph & Signature in the given link and proceed for payment.*
- Step 5:** *After completion of online payment, a hard copy of the application form will be automatically generated with the JSS Academy of Higher Education & Research application number.*
- Step 6:** *Candidates have to take the printout of the application form on A-4 Size sheet of paper. As per the instructions given on the printed application form, the same copy should be retained with the candidate and same may be submitted at the time of document verification/admission.*

HOW TO FILL ONLINE APPLICATION FORM:

*After successful registration, the candidate / user will be directed to **application for admission to MBA course Page**. All the fields / items in this page are mandatory. The candidates have to enter their details and name, Date of Birth, Father's Name, Mother's Name as it is in the SSLC / 10th Standard Marks cards as these items will be carried for further processing. [NOTE: All the fields in this form are mandatory and have to be filled]*

Upload of Photograph and Signature:

The applicant should upload their photographs in online application entry, the applicant should scan their passport size photograph in .jpg format and make available for uploading with the following specifications.

Photograph of the candidate

Width = 3.5 inches, Height = 4.5 inches, Resolution = 200 X 200 dpi and the file size should be less than 50kb.

Signature of the candidate

Width = 3.5 inches, Height = 1.5 inches, Resolution = 200 X 200 dpi and the file size should be less than 50kb.

INTERNATIONAL STUDENTS:

The office of The JSS Academy of Higher Education & Research caters to international students aspiring for admission to the JSS Academy of Higher Education & Research. To check if you are an international student, please refer to the categories listed below:

Categories under International Students Admissions:

- **Foreign National (FN):** *(At the Undergraduate / Postgraduate level): A student is eligible to apply as a Foreign National (FN) if he/she holds a foreign passport.*
- **Person of Indian Origin (PIO):** *(At the Undergraduate / Postgraduate level): A student is eligible to apply as a Person of Indian Origin (PIO) if he/she has a PIO card, and is a citizen of a country other than India.*
- **Non Resident Indian (NRI):** *(At the Undergraduate Level): A student is eligible to apply as a Non Resident Indian (NRI) if he/she has appeared for the last qualifying exam (equivalent to Indian 10+2) outside India. A student is eligible to apply as a Non Resident Indian (NRI) if he/she has appeared either for the 10+2 (equivalent to the Indian 10+2) examination or Graduation outside India. It is mandatory for one of the two qualifying examinations to be given outside India.*

BAN ON RAGGING:

- ❖ *Ragging is a criminal offence as per Karnataka Educational Act 1983 and Hon'ble Supreme Court of India. JSS Academy of Higher Education & Research ensures strict compliance on the prevention of Ragging in any form.*

Definition:

- ❖ *“Ragging” means causing, inducing, compelling or forcing a student, whether by way of a practical joke or otherwise, to do any act which detracts from human dignity or violates his person or exposes him to ridicule or to forbear from doing any lawful act, by intimidating, wrongfully restraining, wrongfully confining or injuring him or by using criminal force to him or by holding out to him any threat of such intimidation, wrongful restraint, wrongful confinement, injury or the use of criminal force. Supreme Court of India has defined ragging as a criminal offence.*

Penalty for Ragging:

- ❖ *No person who is a student of an educational institution shall commit ragging. Supreme Court of India has ordered that “if any incident of ragging comes to the notice of the authority, the concerned student shall be given liberty to explain and if his/her explanation is not found satisfactory, the authority would expel him/her from the institution”.*

Warning:

- ❖ *No leniency will be shown to the offenders involved in ragging. All students are requested to note and co-operate in keeping our JSS Academy of Higher Education & Research and its constituent colleges free from ragging.*
