Candidates who have obtained **JSS AHER MPET- 2019 Rank 1 to 10 (ONE to TEN)** are informed to report to the **Admission Section, JSS AHER Administrative Block** on or before 23.12.2019, 4:00 PM along with the original documents mentioned below, with 3 sets of photocopies of the same. If the candidate does not report before the specified date & time, his/her application will be deemed to be cancelled without any further notice and shall forfeit the claim for admission thereof and the seat will be allotted to the next candidate in order of merit.

10. Experience Certificate (if applicable).
11. Aadhar Card of the student –Copy.
12. Six passport size photographs of which one to be affixed to the online application form in the space provided.
